Why did we start?

(The need for the PPI initiative and/or Why the work was commissioned/or Purpose of attending event/conference if a PPI representative)

Following in past years two very fruitful visits to Belfast by members of Cancer Trials Ireland (CTI) Patient Consultants Committee (PCC) to meet representatives of NI Cancer Research Consumer Forum (NICRCF) this initiative was an opportunity for NICRCF members to join counterparts from CTI PCC in Dublin, at a meeting they were hosting. The objective was to continue to build on this relationship and share learning. The agenda was co-developed with topics of mutual interest to each group.

What did we do?

(Methods-Please comment on how your initiative/or attendance at event/conference met any of the UK Public Involvement Standards) 25-26 September 2024 four members of NICRCF, including Chair, Aidan McCormick, attended the event at Royal College of Surgeons, Dublin. Ruth Boyd, NICRCF PPI facilitator also attended. The Day 1 agenda showcased all-island patient-led research, with a summary of the results of survey in metastatic breast cancer co-presented by Ann McBrien, NICRCF, and Siobhan Gaynor, patient advocate followed by a presentation on the proposed survey for both patients and carers looking at sexual wellbeing after treatment for prostate cancer. NICRCF member Debbie Keatley co-presented with Jacqueline Daly, East Galway and Midlands Cancer Support a discussion/feedback session on a proposal to set up the VOICE (Vision On Information, Confidence and Engagement) 'Science for Patient Advocates' course in Ireland. Day 2 involved presentations by CTI and Irish Cancer Society and discussions were held on project dissemination and wider proposals to support more all-island PPI. Refreshment breaks facilitated opportunities for informal networking also.

What answer did we get?

This collaborative event was useful on several levels – in building and sustaining working / peer patient advocate relationships, sharing knowledge and experience, securing informal commitments for on-going collaboration and strategies to enhance dissemination of all-island research.

Specific outcomes: Due to project awareness Emer Mulvaney (CTI) and Martin Sweeney (patient advocate) were invited, and spoke in Belfast about the all-island patient-led prostate cancer research at the ProEx conference, 18 October 2024, in Patrick G Johnston Centre for Cancer Research. Aidan McCormick is a member of a VOICE (in Ireland) Advisory Group and consultation with NICRCF members also took place in November 2024. Relationships strengthened at this meeting allowed for productive PPI support, involvement and engagement at the 2025 Irish Association for Cancer Research in Belfast in March. A report of the event was produced by CTI.

What should be done now?
